शाहीन बाग में चल रहे धरना और प्रदर्शन को लेकर पिछले एक महीने से दिल्ली- नोएडा को जोड़ने वाला कालिंदी कुंज मार्ग बंद है। नागरिकता संशोधन कानून (सीए) को लेकर हो रहे विरोध के चलते चंद मिनट की दूरी तय करने में घंटों का समय लग रहा है। इसे लेकर नोएडा सेक्टर- 49 के रहने वाले मयंक राज ने राष्ट्रीय मानवाधिकार आयोग (एनएचआरसी) में शिकायत दर्ज कराई है।
